Helping Paws Sanctuary has agreed to take 4 adult cats and 2 kittens. I will transport them to Cape Coral on March 8<sup>th</sup>. I picked up 4 dogs and 2 cats this week. 1 puppy was picked up by Brooke's Legacy Animal Rescue. I transferred a medical case to Canine Castaways. I participated in a Webinar with DocuPets on pet licensing and operating procedures.

**Expense Reports:** After 5 months ended in the fiscal year, the General Fund revenues is at 57.73% and the expenditures are at 67%. The Enterprise Fund revenues is at 59.34% and expenditures at 62.79%. We are operating above the average of 60%. Total revenues is at \$1,397,861.25 and expenses at \$1,291,549.39 leaving an excess of \$106,311.86.
